AREAS OF CONSIDERATION

- Zone 1** On board AKARNG AGR only (Must have held current duty position for a minimum of 18 months) (Any MOS)
 - Zone 2** Alaska Army National Guard Members (Any MOS)
 - Zone 3** Alaska Army and Air Guard Members (Any MOS)
 - Zone 4** Nationwide-Military members eligible for membership in the AKARNG
- *Applicants must meet Chapter 3 physical standards IAW NGR 40-501 and AR 40-501. Initial eligibility requirements IAW AR 135-18, Table 2-1**

MAJOR DUTIES MAY INCLUDE

- The Commander's Initiatives Group (CIG) Officer-In-Charge provides essential direct assistance to the AKARNG Commander by developing, synchronizing and distributing key elements of his mission and objectives to internal and external audiences. The Commander's Initiative Group will serve as the executive advisor to the AKARNG Commander and the Chief of Staff on systems, process improvements, innovations, and concepts. The OIC leads planning and preparation of all strategic communications; plans, coordinates, and supports all engagement activities; and provides operational support as required.
- The CIG OIC is responsible for applying the principles and theories of management science and operations research to solve problems that have previously resisted resolution. The CIG maintains effective communication and engagement with internal and external agencies focused on strategic level issues and crafts and synchronizes messages across multiple formats for dissemination. The OIC will prepare executive level briefings and correspondence for the AKARNG Commander.
- Perform additional duties as assigned

INITIAL ELIGIBILITY CRITERIA

- **SECURITY CLEARANCE – SECRET**
- Physical Demand – Must meet HT/WT standard IAW 600-9
 - Must meet the medical fitness standards for retention per AR 40-501. If PULHES numerical indicator of P3 or P4, then the requirements of AR 600-60 must be met prior to accessioning in the AGR program
- MAJ with at least 5 years TIG, must have completed CGSOC, or its equivalent, as specified in AR 135-155
- Must not have failed selection for promotion on the latest consideration by a mandatory board
- Physical Demand Rating - Moderately heavy. Be able to lift 80lbs occasionally and 40lbs frequently
- **Must be willing to reside in (relocate to) and work in JBER, Alaska commuting area for 3 year tour**
- **If selected for this position, Approval of Command Sponsorship through the Exceptional Family Member Program (EFMP) is required**

PREFERED QUALIFICATIONS

- Desired qualifications: Completion of CGSOC, Advanced Military Studies Program graduate, Lean Six Sigma trained, successful company command

SPECIAL ANNOUNCEMENT CRITERIA

- Upon selection additional medical verification will be required prior to start of AGR tour
- Continuation beyond initial 3-years tour will be subject to evaluation based on AGR Sub tour Continuation Board
- Must complete required MOSQ within one year of assignment
- **CST, GMD, and outlying region assignments only.** There is a three year mandatory active service obligations for accepting a position at these locations and it must be completed while on active status.

Applicants not currently serving on an AGR Tour must be able to serve at least 3 years in the AGR program prior to completing 18 years Active Federal Service (AFS) (any combination of Active Duty, Active Duty Special Work, Annual Training, and/or AGR program for a total of 18 years), or the date of mandatory removal	Individuals who voluntarily resign from the AGR program in lieu of mandatory or involuntary separation action are not eligible to reenter the program without and NGB waiver	If a selectee does not possess the advertised MOS, he/she must complete the required training/assignment criteria within 12 months of being assigned to the position. Failure to do so may result in immediate termination. Extension past 12-months will only be considered if the delay is through no fault of the selectee
Applicants must not be entitled to receive Federal military retired or retainer pay or Federal civil service annuities and not be eligible for immediate Federal civil service annuities	Applicants who voluntarily separated/resign from the AGR program for one or more days are not eligible to reenter the program for one year from date of separation	An applicant's military grade cannot exceed the maximum military authorized grade on the UMR for the AGR position. Acceptance of demotion must be in writing and included in the assignment application package. <u>Application Package will not be forwarded without statement</u>
Must be able to complete at least 10 years of continuous service in an AGR status prior to Mandatory Removal Date	Individuals who have been separated from other military services for cause, unsuitability, or unfitness for military service are not eligible to enter the AGR program without an approved waiver (if applicable)	

APPLICATION PROCEDURES

Interested applicants who meet the eligibility criteria listed in this announcement may apply by submitting the below listed documents to AKNG-Apply@mail.mil. Hard copy applications will **NOT** be accepted. All applications must be typed or printed in legible dark ink and must be signed and dated. **Applications received with an unsigned NGB 34-1 will not be forwarded for consideration.** Complete applications must be received in HRO-AGR office **no later than 1600 of the closing date.** Applicants may include copies of training certificates or any documentation that may be applicable to the position they are applying for but the **complete application package must include all documents listed below.** *Items 2-7 are required by the Human Resource Office to determine qualifications.* If the requested documents are not submitted, a letter of explanation must be included. **Incomplete packages will not be considered for the position vacancy.**

Packet must be in the following order:

1. Resume (Please include personal and military email)

3. Last five Noncommissioned Officer Evaluation Report (NCOER) if applicable
4. Certified copy of Enlisted Record Brief (ERB) as appropriate
5. DA photograph in military uniform (taken within the last 24 months for E6 and above only)
6. Individual Medical Readiness (IMR) Report from MEDPROS with last Physical Health Assessment (PHA) within 12 months. *It is important that you print the report, not the webpage screen.)
7. Statement of all active service performed. The following documents are acceptable : NGB 23B, AHRC 249-E, DD 220, DD 214 and any accompanying DD215 as applicable.

INSTRUCTIONS TO COMMANDERS/SUPERVISORS: This position vacancy announcement will be given the broadest possible dissemination. A copy of this announcement will be posted on your unit/activity bulletin board. Selecting supervisor will contact qualified applicants for interviews. After the Human Resources Officer (HRO) approves the selection package, the HRO office will send a notification letter to all applicants of their selection/non-selection. The selection of an applicant is not final until the individual has been notified by the HRO-AGR. After the selecting supervisor makes a selection, the "routing" of the selection package begins and ends with HRO.
