Subject: DMVA Calendar Year 2026 State Active-Duty Rates from January 1, 2026

This memo updates the State Active Duty (StAD) Pay Memo. There has been a 3.8% pay increase to active-duty military members effective January 1, 2026.

Alaska Statute (AS) [26.05.010](#) establishes the Alaska Militia. The Militia is divided into two classes: (1) the organized militia, consisting of the Alaska National Guard, the Alaska Naval Militia, and the Alaska State Defense Force; and (2) the unorganized militia, consisting of all qualified persons available for service but not serving in the organized militia.

Under AS [26.05.260\(b\)](#), when active state service is authorized by the governor or by the adjutant general as the governor's designee, members of the organized militia are entitled to receive, for each day of active service under [AS 26.05.070](#), pay in an amount equal to the pay received by a member of the regular armed forces of the United States in the same grade and rank as the member of the organized militia. This amount is equivalent to the calendar year 2026 active duty pay, basic allowance for subsistence (BAS), and basic allowance for housing (BAH).

Accordingly, State Active Duty (StAD) pay will be equal to the same grade and rank as a member of the regular armed forces of the United States.

The rates attached to this memo are effective as of January 1, 2026, and shall remain in effect until January 1, 2027, unless a revised military pay schedule is received.

5. Basic pay for pay grades O-6 and below is limited to the rate of basic pay for Level V of the Executive Schedule during calendar year 2025, which is 15,258.30.

6. O-1, O-2, and O-3 rates do not apply to commissioned officers who have been credited with over 4 years (i.e., at least 4 years and 1 day) of active duty service as an enlisted member or as a warrant officer or as both an enlisted member and a warrant officer.

2. Basic pay for senior enlisted member (grade E-9) is \$11,166.90 regardless of years of service while serving as:

a. Senior Enlisted Advisor of the Chairman, Joint Chiefs of Staff;

b. Sergeant Major of the Army;

c. Master Chief Petty Officer of the Navy;

d. Chief Master Sergeant of the Air Force;

e. Sergeant Major of the Marine Corps;

f. Chief Master Sergeant of the Space Force;

g. Master Chief Petty Officer of the Coast Guard; or

h. Senior Enlisted Advisor to the Chief of the National Guard Bureau.

3. If a member is placed on terminal leave pending retirement immediately following the completion of service as the senior enlisted member of a Military Department, the member is entitled to the higher senior enlisted pay \$11,166.90 up to a maximum of 60 days. If a member is hospitalized, and during or immediately before such hospitalization, completed service as the senior enlisted member of that Military Department's Armed Force, the member will continue to be entitled, for not more than 180 days while so hospitalized, to the rate of basic pay authorized for a senior enlisted member.

4. Must have 4 months of active duty or more.

5. Basic pay for an E-1 with less than 4 months of active duty is \$2,225.70.

The BAS II rate is twice the rate of standard enlisted BAS and must be authorized the Secretary of the Military Department concern.
