- Identify training needs and ensure appropriate training is conducted and documented.
- Implement upgrade training programs and maintain accurate training records.

## Operational Planning & Execution:

- Plan and manage weekly/monthly work schedules, setting priorities and deadlines.
- Determine resource requirements (skills, materials, equipment) for effective operations.
- Coordinate with other units to ensure seamless workflow and support.

## Administrative Oversight:

- Participate in personnel selection, performance evaluations, and disciplinary actions.
- Maintain accurate production reports and records in compliance with regulations.
- Implement and enforce safety regulations and ensure a safe working environment.
- Review and improve work methods to optimize efficiency and effectiveness.
- Administer and promote Government-wide programs and policies (e.g., suggestion program, cost reduction program).

## Readiness & Compliance:

- Prepare for and participate in readiness evaluations, inspections, mobilization exercises, and command support activities.
- Ensure compliance with all applicable safety regulations.
