




**Amendment 1 of MEMORANDUM**

Subject: DMVA Calendar Year 2025 State Active-Duty Rates from April 1, 2025

There has been a 4.5% pay increase to active-duty military members effective January 1, 2025, with the ranks of E-1 through E-4 receiving an additional 10.0% in April. The rates provided in this Amendment 1 will reflect April -December 2025.

Alaska Statute (AS) [26.05.010](#) establishes the Alaska Militia. The Militia is divided into two classes: (1) the organized militia, consisting of the Alaska National Guard, the Alaska Naval Militia, and the Alaska State Defense Force; and (2) the unorganized militia, consisting of all qualified persons available for service but not serving in the organized militia.

Under AS [26.05.260\(b\)](#), when active state service is authorized by the governor or by the adjutant general as the governor's designee, members of the organized militia are entitled to receive, for each day of active service under [AS 26.05.070](#), pay in an amount equal to the pay received by a member of the regular armed forces of the United States in the same grade and rank as the member of the organized militia. This amount is equivalent to the calendar year 2025 active duty pay, basic allowance for subsistence (BAS), and basic allowance for housing (BAH).

Accordingly, State Active Duty (StAD) pay will be equal to the same grade and rank as a member of the regular armed forces of the United States.

The rates attached to this memo are effective as of April 1, 2025, and shall remain in effect until January 1, 2026, unless a revised military pay schedule is received.

There is a special type of Basic Allowance for Housing (BAH) known as BAH Transit, BAH Type II, BAH Non-Locality, or BAH Reserve, depending on what branch you are in and your status. This BAH is paid when you are in a travel status from one permanent duty station to another. It is also paid to reservists and Guard members on active duty for less than 30 days.

Normally, your locality housing allowance ends on the date you check out of your old duty station and begins when you check into your next station. This BAH Type II will be paid to you while you are in transit between the two duty stations.

The amount does not vary by geographic location. BAH RC/Transient is set based on the national average for housing. BAH is published annually and is determined by increasing the previous year's table by the percentage growth of housing costs.

**NOTES:**

1. BAS II is the monthly rate that may be payable to enlisted members on duty at a permanent station and assigned to single (unaccompanied) Government quarters, which do not have adequate food storage or preparation facilities, and where a Government mess is not available, and the Government cannot otherwise make meals available. The BAS II rate is twice the rate of standard enlisted BAS and must be authorized the Secretary of the Military Department concern.
2. The BAS rate effective January 1, 2019 is the same as the BAS rate for January 1, 2018.
3. The BAS rate effective January 1, 2017 is the same as the BAS rate for January 1, 2016.
