We therefore facilitate the procedures necessary to stay compliant with applicable laws and regulations in support of AKARNG's mission.

We provide guidance, training, and other support necessary for AKARNG to sustain its mission while also protecting the environment and ensuring stewardship of the natural and cultural resources in Alaska.

AKARNG is subject to annual environmental compliance training requirements. These include:

- Basic spill response training
- SPCC training for personnel at facilities that are regulated by a Spill Prevention Control and Countermeasures (SPCC) plan
- Storm-Water Pollution Prevention training
- Storage Tanks (ASTs and USTs)
- Hazardous Waste Management

Water & Spill Response

- Spill response/POL storage
- Spill Prevention Control and Countermeasures plan annual review (**required for facilities with a SPCC plan*)
- Stormwater management (**required for facilities with a SWPPP*)
- Routine tank inspections
- Oil-Water-Separator best practices

Hazardous & Universal Waste

- Material Disposal Request Form (MDRF) for waste turn-ins
- Managing wastes on site (labeling & containerizing)
- Responsibilities and difference between SQGs and VSQGs
- Understanding potential hazards
- Universal waste program

Air Quality

- Generator run logs
- Potential to Emit (PTE) and how to identify new sources of emissions (e.g., generators, boilers, paint operations, fugitive dust, solvent part cleaners)
- Air quality & smart ash burner/burn barrel best practices

Training Checklist

- ☒ POL-handling personnel: If you haven't received spill training in the last 12 months, reach out to your Unit's Environmental Officer or give us a call.
- ☒ You are oil-handling personnel and your facility has a Spill Prevention Control and Countermeasures (SPCC) plan? Schedule training with us if it has been over 12 months since your last SPCC training. This training is a regulatory requirement.
- ☒ Do you work at a facility with a Stormwater Pollution Prevention Plan (SWPPP)/that is exposed to stormwater? If you haven't received SWPPP training in the last 12 months, give us a call. This training is a regulatory requirement.
- ☒ Do you work at a maintenance shop/armory and handle hazardous waste? Have you received Hazardous Waste training in the last 12 months or within 6 months of employment? If not, reach out to your Unit Environmental Officer or give us a call.
- ☒ You have been appointed as an Environmental Officer and haven't received your EO training or it has been over 12 months since your last training? Call us to schedule training.
